## General Information for Applicants

- Attach 2 passport size photos (one of each adult), to the form if you are applying for Family membership
- Attach 1 passport size photo to the form if you are applying for Single membership or Family Top-up
- All membership fees are from and after 1<sup>st</sup> June to 31<sup>st</sup> December 2025
- Nominators and Seconders **must be financial ordinary (voting) members** of the club
- All membership applications will be displayed on the club notice board for a period of two weeks prior to being sent to the Executive Committee for approval
- Executive Committee meetings are normally held on the second week of each Month.
- Temporary membership entry cards are issued upon receipt of membership application and payment
- Family membership is for husband and wife and their children not exceeding 18 years of age
- Where the cadet is the child of a current member of the club, no nomination fee is payable
- Rights of membership is not transferrable and not refundable
- Gym membership is additional to club membership and charged per person - Not refundable
- All membership renewal payments are due on the 31<sup>st</sup> December of each year.
- Nomination fee is a one-off payment made at the start of each new membership.
- Every member has a right to use the facilities of the Club and enjoy the privileges it can impart and, as their becoming a member is a voluntary act on their part, their acquiescence in these Rules and the By-laws as amended from time to time is implied.

**Note:** Fly-In Fly-Out (FIFO) workers to PNG are deemed to be Port Moresby residents for membership purposes. As they are not considered to be visitors, FIFO workers are not eligible for honorary membership, temporary membership or country membership; they are to be considered for full membership only.
